Call to Order:

1.3 H.523 Condemnation Training

The training involved education regarding the methodology of condemnation appraisals, Vermont law that governs the determination of damages resulting from a condemnation for a state highway project, and the provisions of the federal Uniform Relocation Assistance and Real Property Acquisition Properties Act related to the determination of damages.
